Opinion: Broken federal promises regarding student loan forgiveness

Congress created a student loan forgiveness program in 2007 to draw people to vital but relatively low-paid careers with a promise: after a decade, if borrowers faithfully paid their debts and pursued their work, they would have the remainder of their student loans written off. The program promised students that if they stayed with their vital but low-wage professions, their debts would be wiped clean—but they weren't.

Facts: Education Legislation Pending Action

There are currently 3,161 Legislation items pertaining to Education in Congress. 490 Bills pertaining to Elementary and Secondary Education have been introduced. Two bills have been approved by the House and sent to the Senate: H.R. 2528: STEM Opportunities Act of 2019, To direct the Director of the Office of Science and Technology Policy to carry out programs and activities to ensure that Federal science agencies and institutions of higher education receiving Federal research and development funding are fully engaging their entire talent pool, and for other purposes. H.R. 4372: MSI STEM Achievement Act, to direct Federal science agencies and the Office of Science and Technology Policy to undertake activities to improve the quality of undergraduate STEM education and enhance the research capacity at the Nation's HBCUs, TCUs, and MSIs, and for other purposes. H.R. 258 the Senate on September 26, 2019 and H.R.4372 was sent on December 10, 2019.

Only one bill has been signed into law: H.R. 276: Recognizing Achievement in Classified School Employees Act. The Bill directs the Secretary of Education to establish the Recognizing Inspiring School Employees (RISE) Award Program Recognizing Excellence exhibited by Classified School Employees providing services to students in prekindergarten through high school. This bill was signed by President Trump on April 12, 2019. Currently H.R. 5363 has been approved by both the House and Senate and has been sent to the President on December 10, 2019. H.R. 5363: Fostering Undergraduate Talent by Unlocking Resources for Education Act: The

bill reauthorizes mandatory funding programs for historically Black colleges and universities and other minority-serving institutions, and for other purposes.

Proponents are looking for tax legislation that helps workers and families first by expanding the Earned Income Tax Credit (EITC) and Child Tax Credit (CTC).
